SAN JOSE, CA, January 30, 2008 – SJW Corp. (NYSE: SJW) announces today that the Board of Directors approved a \$0.04 per share increase in the annual dividend to \$0.645 per share. A quarterly dividend of \$0.16125 per share is payable on March 1, 2008 to shareholders of record at the close of business on February 11, 2008.

SJW Corp. will release its 2007 full-year and fourth quarter financial results after the close of the market on Wednesday, February 20, 2008. W. Richard Roth, President and Chief Executive Officer, and Angela Yip, Chief Financial Officer and Treasurer, will review the results in a webcast presentation at 10:00 A.M.
