## **Cambrian Reservoirs Replacement Project**

SJW is planning to start a multi-year construction project in Spring of 2024 to build two new tanks providing 16 million gallons of potable water storage to our customers. The reservoir replacement project is scheduled to be completed in September 2027. Cambrian Station currently consists of two large earthen embankment reservoirs with storage capacity of 12.1 million gallons and 3.9 million gallons, respectively. The first reservoir was originally constructed in 1890 and the second in 1921. The existing reservoirs have reached the end of their useful life. The new tanks will have a more resilient structure with a long service life (100± years), lower maintenance requirements, and improved seismic stability. Work will be done Monday through Friday between the hours of 7:00 AM and 7:00 PM, in accordance with City of San Jose ordinances.


